



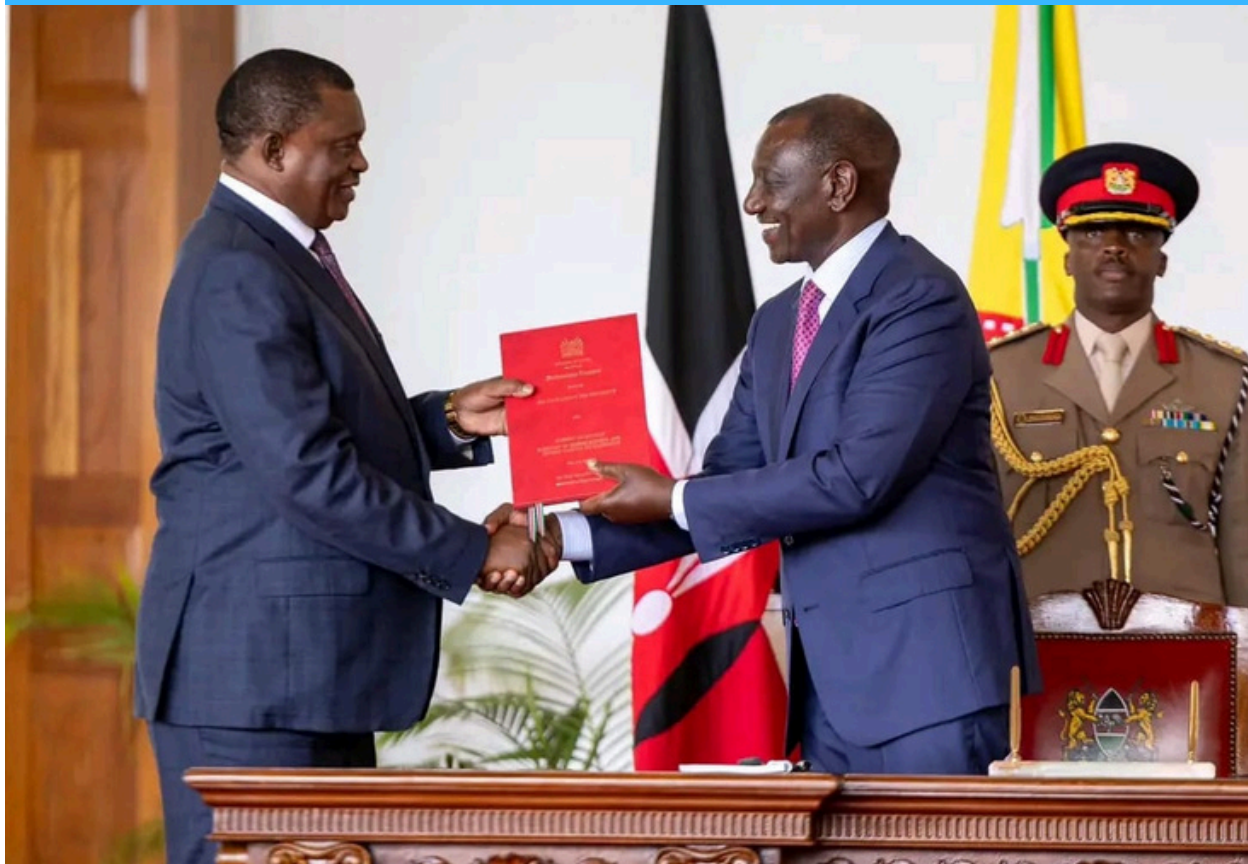

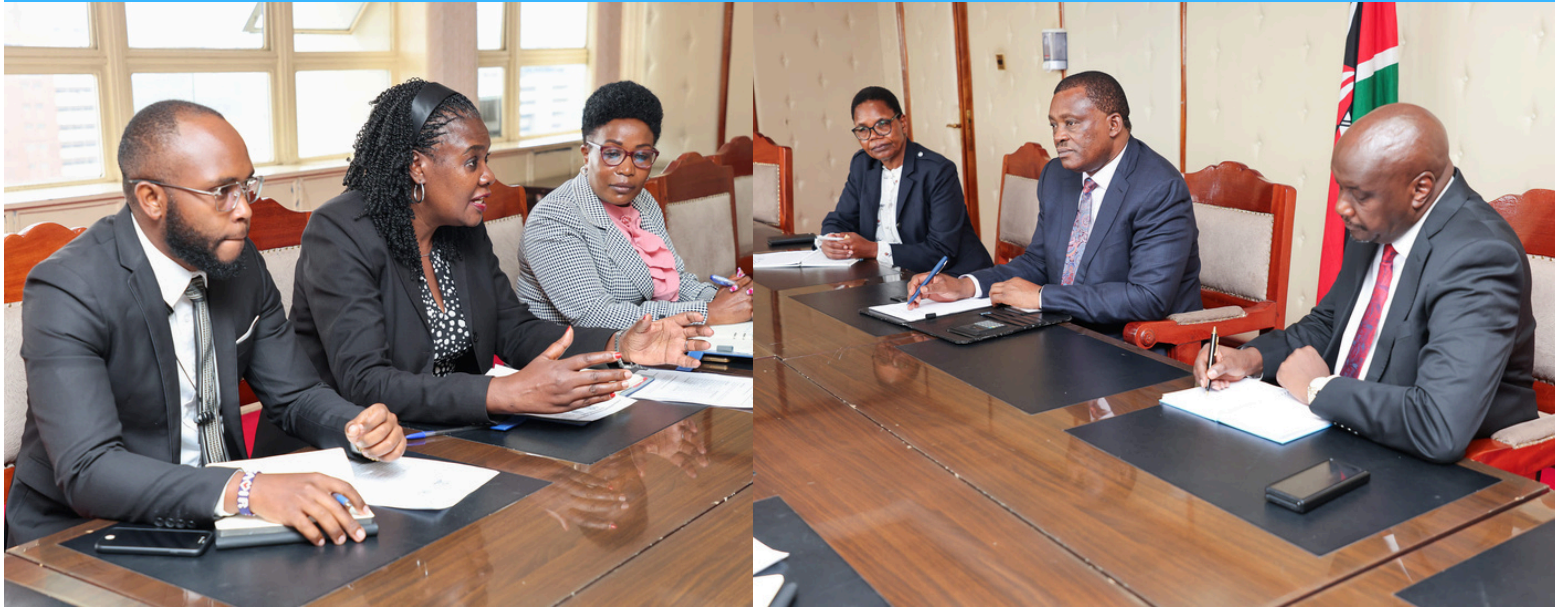

CS MUTURI MEETS HRMPEB LEADERSHIP



Cabinet Secretary Hon. Justin Muturi held a productive meeting with the Human Resource Management Professionals Examinations Board (HRMPEB) to discuss key issues aimed at advancing human resource management and development in Kenya. The discussions revolved around ways to strengthen professionalism, enhance collaboration, and support HRMPEB in executing its mandate effectively.

One of the key areas of focus was the integration of the Certified Human Resource Professionals (CHRP) qualification into the scheme of service. This will ensure greater emphasis on certification and professionalism, elevating the standards of HR practice in the public sector. We also discussed the need for an overarching Act to harmonize human resource matters across both the national and county government levels, ensuring consistency and efficiency.

HRMPEB highlighted the importance of reinstating exchequer funding to sustain its critical operations. Additionally, we deliberated on the overlapping roles of TVET/CDACC and HRMPEB, emphasizing the need to clearly demarcate their mandates. This will pave the way for meaningful collaboration between the two institutions in advancing human capital development in Kenya.

Hon. Muturi reiterated his commitment to support HRMPEB in fulfilling its objectives. Strengthening our human resource management systems is key to driving Kenya's development agenda, and we remain dedicated to making this vision a reality.

The bill seeks to provide an over-arching framework to enhance human resource management and development in the country.

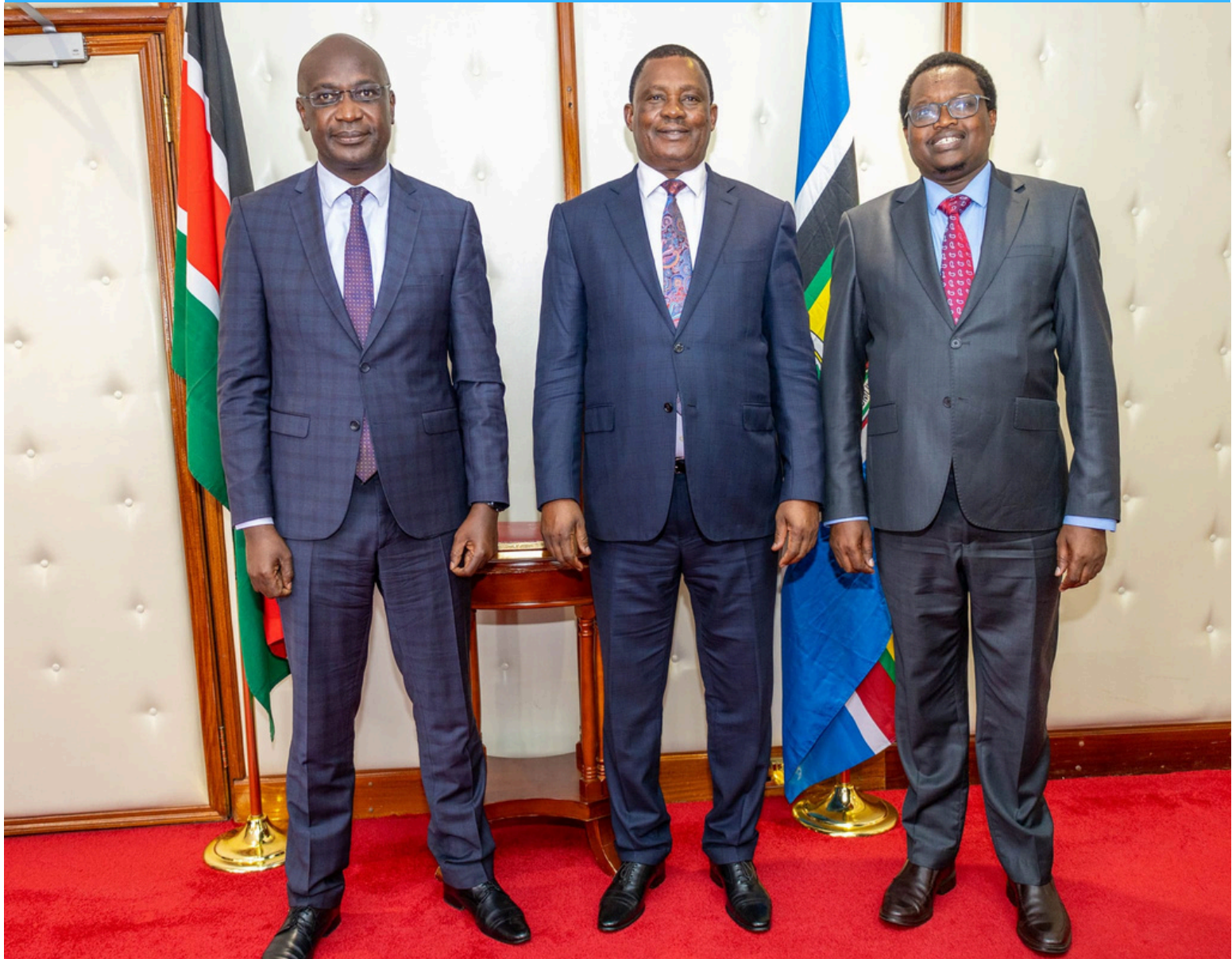
The validation workshop was presided over by Principal Secretary Ministry of Public Service and Human Capital Development Mr. Amos Gathecha.

PSSF is a contributory pension arrangement to provide retirement benefits to officers in service of the Government.

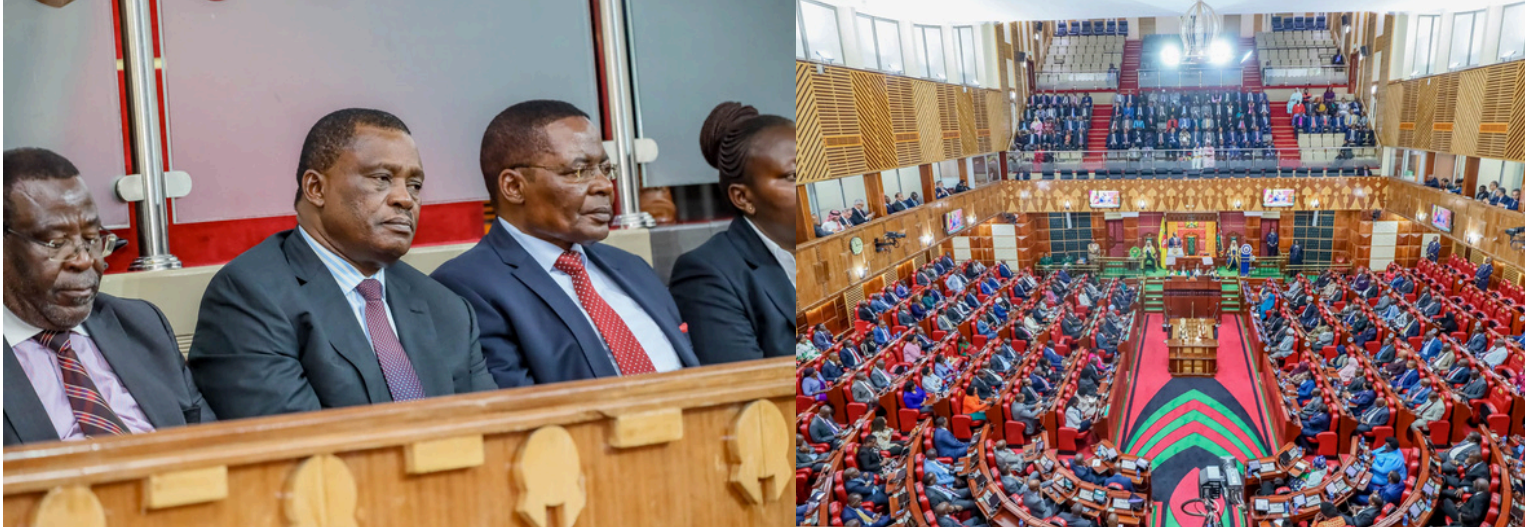
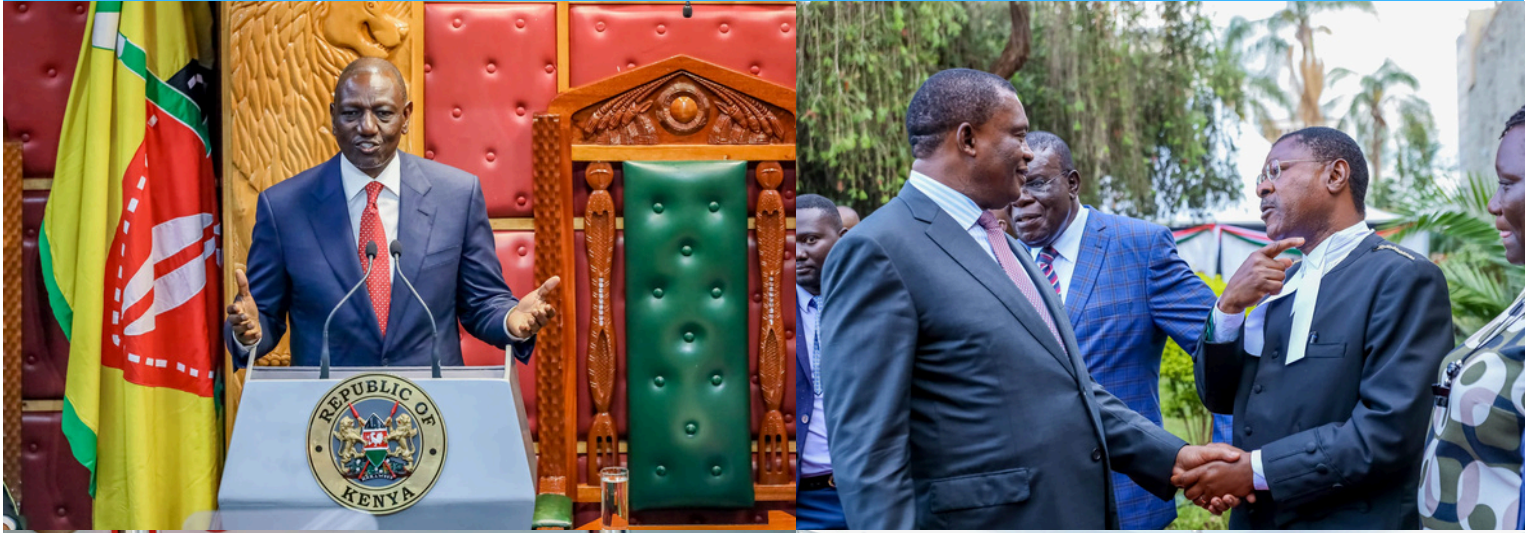
Present in the meeting also was Dr. Jonah Aiyabei who is the Fund's Chief Executive Officer.
